- Advanced novel arguments before the Divisional Court on the leave-to-appeal threshold for interlocutory family court orders, prompting discussion of procedural reform within the bar.
- Counselled a politically exposed person in sensitive divorce proceedings involving assets in European nations with links to a prominent South Asian family, navigating complex assetprotection and privacy issues.
- Achieved successive summary-judgment victories recognizing a Chinese divorce, compelling sale of Ontario real estate and defeating further support and property claims asserted in Canada.
